The Hedrick City Council met in regular session on Monday, June 1, 2020, at 6:30 p.m. in the Community Center, with Mayor Crawford presiding. Council present: Tamie Reynolds, Mike Mefford, Jeremy Greiner and Travis Bunnell. Council absent: Kathryn Cernic. Others present: Jeff Emery, Cindy Emery, Kaitlyn Emery, Nicolette Proctor, Reilly Mitchell and Austin Crowe.

Greiner made a motion to approve the agenda. Reynolds seconded. Roll call – all ayes. Motion carried.

Bunnell made a motion to approve the minutes of the May meeting. Mefford seconded. Roll call – all ayes. Motion carried.

Nicolette Proctor and Reilly Mitchell, from South Ottumwa Savings Bank talked with the Council about the new sidewalk that they are planning to be put in front of the bank this summer. They have a bid for \$8,800.00 that they have accepted. They were wondering about reimbursement for this or a portion of this amount, as the City has done in previous years. The Council decided to table this discussion until the July meeting.

The next item the Council discussed was allowing activities at the Community Center and Civic Center due to the COVID 19 Pandemic. Jeff, Cindy and Kaitlyn Emery were present to discuss having the Pekin Prom at the Civic Center on Saturday, June 20, 2020. They stated that they would follow any guidelines necessary for using the Civic Center. Reynolds made a motion to not rent or let the buildings be used by anyone until further notice, due to the uncertainty of the pandemic. Greiner seconded. Roll call – Ayes: Greiner, Reynolds and Mefford. Nays: Bunnell. Motion carried. Mefford then made a motion to close the parks until further notice. There was no second to this motion. After much more discussion, Mefford made a motion to rescind the prior two motions and to approve the use of the Community Center and Civic Center for scheduled activities and to open the parks, with the bathroom to remain closed in the Big Park on the Highway. The bathrooms will be open at the Ball Diamonds, with the Ball Team Coaches responsible for the cleaning. The concession stand will also be open to sell only drinks, popsicles and prewrapped food. No prepared food will be allowed. All city owned buildings and park users must follow the CDC Guidelines including the Pekin Prom will be required to take temperatures of all who enter. Bunnell seconded. Ayes: Bunnell, Greiner and Mefford. Nays: Reynolds. Motion carried.

Bunnell made a motion to approve the Clerk's Financial Report and introduced Resolution #11-2020, approving the transfer of \$77,252.17 from Sewer Hauling to General Checking for the sewer loan payment. Mefford seconded. Roll call – all ayes. Motion carried.

Bunnell made a motion to approve the Employee's Time Cards. Greiner seconded. Roll call – all ayes. Motion carried.
